Exchange of Medical information
<p>Your GP and your pharmacists may connect their computers to a secure and reliable system called the National Exchange Point (LSP). They can then use it to share the relevant parts of your medical data. Another doctor or pharmacy can access your medical data through LSP using a secure card and password. But only if this is necessary for your treatment. Your medical records are not stored in a central database. They are kept on the computer systems used by your GP and your pharmacists.</p> <p>Health insurers, company doctors and employers cannot access your medical data. Another doctor or pharmacist can only access your medical data if it is necessary for them to be able to help you quickly, properly and safely.</p>
